The Board has been informed by the Management that currently, various financing arrangements are being considered by the Management and their financier(s) have indicated the preference of the engagement of their respective preferred choice of professional advisers should their funds be deployed for the

Possible Management Offer. Hence currently, the immediate engagement of the financial advisor(s) to the Management is not practicable prior to the finalisation of the Management's financing arrangements.
