**VOLUNTARY ANNOUNCEMENT**  
**UPDATE ON THE LAWSUIT AGAINST THE SAMR AND**  
**ADMINISTRATIVE REVIEW PROCESS**

This announcement is made on a voluntary basis by Greatview Aseptic Packaging Company Limited (the “**Company**”, which together with its subsidiaries, shall be collectively referred to as the “**Group**”).

Reference is also made to the announcement issued by the Company on 8 November 2024 relating to the administrative lawsuit against the SAMR (the “**Previous Announcement**”). Unless otherwise defined in this announcement, capitalised terms used in this announcement shall have the same meaning as they are referred to and defined in the Previous Announcement.

The board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company (the “**Shareholders**”) regarding recent developments related to the administrative lawsuit against the SAMR.

As disclosed in the Previous Announcement, the Company commenced an administrative lawsuit (the “**Lawsuit**”) against the SAMR in March 2024 concerning SAMR’s decision referenced in the SAMR Notice. The court hearing took place on 20 November 2024.

The Company received a legal analysis from the PRC law firm handling the current administrative lawsuit for the Company on 19 December 2024 (the “**Legal Analysis**”), indicating that the lawsuit against the SAMR is currently under review and awaiting judgment. The Company retains the right to appeal any adverse decision that may arise from this litigation.

Additionally, the Board would like to inform Shareholders that the Company has initiated an administrative review process concerning the notice from the SAMR dated 15 November 2024 addressed to the Company and Shandong NewJF Technology Packaging Co., Ltd.\* (山東新巨豐科技包裝股份有限公司) (“**Shandong NewJF**”) and will keep Shareholders informed of any significant developments regarding this case.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
